Very unusual aspect to this sale was the fact that the first 5 parcels were being sold subject to a "Crop Share" lease which extended for over 13 years to February, 2027. In the event the tenant that held that lease was the successful bidder for those 5 parcels. Our sources tell us that they would likely have sold for \$12,000 or more had there been no lease.

437.83 Acres actually sold at \$8,900/Acre with 132 PI for \$67.86/PI Point. Parcel #6-120 acres without a lease beyond this year sold for \$11,100/Acre with 130.6 PI for \$85.01/PI Point.

460 Acres sold at auction in Lee County-September 25-Ashton Township-6 miles west of Rochelle. Farmland Sold in 4 tracts. There was also an 18 acre quarry bid up to \$57,000-a bid deemed unacceptable to the sellers.
